Participation in the VIZIO Sweepstakes (“**Sweepstakes**”) constitutes your agreement to be bound by these VIZIO Sweepstakes Official Rules (“**Official Rules**”).

1. Sweepstakes.

- A.** The overall Sweepstakes commences at 12:00 AM Pacific Time (“**PT**”) on September 4, 2020 and ends at 11:59 PM PT on December 31, 2020 (“**Sweepstakes Period**”).
- B.** The overall Sweepstakes will be comprised of a series of individual weekly sweepstakes (“**Weekly Sweepstakes**”) beginning on September 4, 2020 and ending on December 31, 2020. 2. Sponsor. VIZIO, Inc. (“**VIZIO**”), 39 Tesla, Irvine, CA 92618. This Sweepstakes is in no way sponsored, endorsed or administered by, or associated with any other person or entity, including Square Enix, Marvel, or Sony (except as a prize provider), or any other person or entity to which the Sweepstakes or its Prizes are related.

3. Eligibility. Open only to living individual legal residents of the fifty (50) States of the United States and the District of Columbia and who are at least 18 years of age or older (or the age of majority in their state of legal residence, whichever is older) and have an active, valid email account as of the commencement of each Sweepstakes Period. 4. How to Enter. To enter the Sweepstakes, each participant must completely fill out an entry form located at www.vizio.com/playavengers (“**Entry**”). For any Entry that does not meet the above



specifications or does not comply with these Official Rules, such Entry may be disqualified in Sponsor's sole discretion.

There is a limit of a total of one (1) Entry per participant in each Weekly Sweepstakes. For purposes of each Weekly Sweepstakes, a week begins at 10:00 AM PT each Friday and ends at 9:59 AM PT each Friday during the Sweepstakes Period (a "**Sweepstakes Week**"), except that the Sweepstakes Week beginning on December 25, 2020 at 10 AM PT will end at 11:59 PM PT on December 31, 2020. Multiple Entries from one person are not permitted in any one Weekly Sweepstakes.

Any participant who attempts to participate under multiple identities or uses any device or artifice to enter multiple times in a Weekly Sweepstakes in violation of applicable Entry limitations may be disqualified. Any use of robotic, repetitive, automatic, programmed or similar Entry methods or agents will void any and all Entries made by, or associated with, the applicable participant. In the event of a dispute over who submitted an Entry, the authorized account holder of the email account provided in connection with the Entry, as of the actual time of Entry, will be deemed to be the participant.
